

TERMS OF USE

Last updated: April 6th 2026

1. Introduction

Please read these terms and conditions carefully before accessing and using the Aleta Index online platform (hereinafter collectively referred to as “**Service**”), which is owned and operated Aleta Index Ltd. (hereinafter referred to as “**we**”, “**our**” or “**us**”).

These terms, as modified or amended from time to time, constitute a binding contract between us and you (“**you**”, “**your**” or “**user(s)**”). These terms and conditions (hereinafter referred to as “**Terms of Use**”) as well as the Privacy Policy and all other applicable laws and regulations govern your access, and use of the Service.

By accessing or using the Service, you agree to be bound by these Terms. If you do not agree, you must not use the Service.

2. Description of the Service

The Service allows users to select a company ticker and a timeframe for the purpose of surfacing the narratives coming from news streams, analysing and generating narratives reliability assessments and credibility indicators, or similar informational outputs (“**Analysis**”).

The Analysis is generated using automated systems, machine learning models, and publicly available data sources and does not constitute factual verification, professional advice, or journalism.

3. Eligibility

You must be at least **18 years old** (or the minimum age required in your jurisdiction) to use the Service. By using the Service, you represent that you meet this requirement.

Minors who use and/or access the Services are deemed to be doing so under the express consent and permission of their parent/legal guardian. In such cases, these Terms of Use are binding as between us and the parent/legal guardian of such minor.

4. User Account

You may be required to register with the Service as a User by filling out the registration form provided in the sign-up area of the Service. During registration or while accessing the Service, You may be required to furnish certain information and details, including Your name, e-mail id, contact number, and any other information that is deemed necessary by us. (“**Account Information**”).

You are responsible for maintaining the confidentiality of Your account and password and for restricting access to Your device to prevent unauthorized access to Your account or password.
